

**THE HONORABLE CITY COUNCIL OF THE CITY OF LOVELOCK MET IN REGULAR SESSION ON OCTOBER 2, 2018 AT THE LOVELOCK CITY HALL AT 7:00 P.M.**

Mayor Giles called the meeting to order at 7:00 p.m.

**PUBLIC COMMENT-PERSONAL COMMUNICATION-CORRESPONDENCE:**

There were no comments from the public.

**MINUTES REVIEW-APPROVAL:**

Council member Rowe moved to approve the September 18, 2018 regular City Council meeting minutes as presented.

Motion carried unanimously.

**BUSINESS IMPACT DETERMINATION:**

After review and consideration of the probable effect that each agenda item for this meeting could have on a "business" as defined by statute, Council member Donaldson moved to make a finding that no item on this meeting agenda appears to impose a direct and significant economic burden on a business or directly restrict the formation, operation or expansion of a business.

Motion carried unanimously.

**SEWER-DISPOSAL ACCOUNT DELINQUENCIES / ADJUSTMENTS / REFUNDS:**

City Clerk Booth presented a list of deposits and requested the amounts be applied to the customers' accounts.

Council member Donaldson moved to apply the deposits to the accounts as presented.

Motion carried unanimously.

**2018 GENERAL ELECTION / BALLOT INITIATIVE QUESTION 3 "ENERGY CHOICE" OPPOSITION PROPOSAL:**

Mayor Giles presented a draft resolution prepared by Giles and Legal Counsel Maher to express opposition to and urge a "no" vote on the 2018 General Election Question 3 "Energy Choice" ballot initiative to amend the Nevada Constitution to allow deregulation of the electric utility industry in Nevada.

After discussion, Council member Murphy moved to approve and adopt proposed Resolution 2018-02 as presented.

Motion carried unanimously.

**2018 GENERAL CITY ELECTION / DECLARE SINGLE CANDIDATES ELECTED:**

Proposed Resolution 2018-03 was presented declaring: (i) Starlin Gentry as the single candidate filed for City of Lovelock Council Seat B elected to the office of City of Lovelock Council Seat B; and, (ii) Patricia Rowe as the single candidate filed for City of Lovelock Council Seat C elected to the office of City of Lovelock Council Seat C.

Council member Donaldson moved to approve and adopt proposed Resolution 2018-03 as presented.

Motion carried unanimously.

**CITY COUNCIL MEETING CANCELLATION / NOVEMBER 6, 2018:**

Council member Murphy moved to approve the cancellation of the November 6, 2018 regular City Council meeting.

Motion carried unanimously.

**CITY WASTEWATER TREATMENT PLANT TANK RECOATING PROJECT:**

Mayor Giles reported that RDC (the project contractor) returned on September 24; the sandblasting and painting testing was completed, and corrections were made to areas that failed the testing; and, the tank painting and pipe painting is ongoing and more testing is scheduled for later this week. The project should be completed soon. No action was taken.

**STAFF-COUNCIL REPORTS-PROPOSALS:**

Police Chief Mancebo reported the new police officer is doing well with the field training. In order to be compliant with state law, the parking area across the street from City Hall has been designated as an "Internet Safe Zone" and a sign has been posted.

Council member Murphy commented on the list presented by the staff regarding the trash pick-up rates charged by the surrounding municipalities and suggested the City should consider either an extra charge for additional pickups or an increase across the board. The Council indicated they want to consider an ordinance which will provide for graduated (over time) fee increases for all types of residential and commercial waste pick up.

Council member Rowe inquired about weed notices sent to 905 and 945 Elmhurst. City Clerk Booth said she will check on the status.

Mayor Giles reported attending the POOL/PACT meeting and workshops. Giles advised of the changes NDOT is proposing for the Cornell-Main Street stop light and the streets in front of the Courthouse. Giles asked the Council members to contact Legal Counsel Maher to discuss their thoughts regarding the Tourism and Recreation Board.

Council member Murphy moved to approve vouchers and payroll through number 45739.
